



## Nova Scotia Council Commissioner's Award

Nova Scotia Council Commissioner's Award recognizes adult and youth members of Nova Scotia Council who demonstrate significant commitment to scouting in Nova Scotia and follow the elements of the Canadian Path.

This can be identified through the commendation process in the Scouts Canada recognition program, or a letter of nomination from scouting members in the Nova Scotia Council.

*“Significant” is defined as leadership and commitment that exceeds the performance of ordinary duties and expectations of the Canadian Path Program.*

### Eligibility

1. Must be a current member of Nova Scotia Council and be in good standing. **Active, all training and screening current, no disciplinary action, suspension or under review by safe scouting**
2. A member of Nova Scotia Council for a minimum of two years.
3. Clearly demonstrates commitment to Scouting and the elements of the Canadian Path.
4. Has positively benefited others as a result of their work and commitment.

### Nomination Process

Nomination statement must include the impact the individual has made on others in the Scouting community. Nominations may be made via the commendation process in [myscouts.ca](http://myscouts.ca) or by submitting the attached form to the Council Recognition Advisor at the Atlantic Services Center, or by email to [gwen.mosher@scouts.ca](mailto:gwen.mosher@scouts.ca).

The award/nomination will be reviewed and presented at the discretion of the Nova Scotia Council Key 3 or designates with the assistance of the council recognition advisor.

The award consists of a pin to be worn on the right pocket flap of the uniform and a certificate. This award is recognized by Scouts Canada as part of the individual's recognition profile in [myscouts.ca](http://myscouts.ca).
